Vlad reports the SW Dist Council may soon join the Parks Commission. Metro is revising some bus routes. The SW police advisory are aware of the coming traffic problems, with the wastewater construction and the Rapid Ride at the same places.

Susan reports that there have been break-ins and attempted break-ins along Fauntleroy Way, hence all the block watch signs.

Ferries Advisory meeting was held by conference call. No changes to report for Fauntleroy.
